#### Introduction

Effecting Academic Writing is a three-book series intended to usher students into the world of academic writing. The goal of the series is to provide students and their teachers with a practical and efficient approach to learning the skills, strategies, and knowledge that are necessary for succeeding in content coursework. A parallel goal is to provide opportunities for students to explore their opinions, discuss their ideas, and share their experiences through written communication. By guiding budding writers through the experience of composing various types of short papers, we hope to provide students with the tools and the confidence necessary for college success.

#### The Short Essay

Book 2 of Effective Academic Writing, The Short Essay, introduces students at the intermediate level to three- and four-paragraph essays. The first unit provides a thorough review of paragraph structure and mechanics to consolidate knowledge before moving on to more extended writing. Each of the following five units then addresses a particular rhetorical mode and provides user-friendly guidance to mastering the form. The book also offers numerous opportunities for practicing relevant language points.

All language presentations and practice are correlated to Grammar Sense 2.

Book 2 contains several features designed to support students in developing the skills that they need for college writing:

- . Each unit contains an adapted authentic text to provide ideas and context for the assignment.
- · At strategic points in the unit, students read and analyze authentic student essays to see how other students have written on the same or similar topics.
- · Each unit contains concise and effective language presentations designed to develop students' understanding of rhetorical modes, and to improve their grammatical accuracy.
- · Each unit offers useful writing outlines so that students can learn to plan and to structure their writing.
- · Each unit offers collaborative learning activities allowing students to work together and share ideas.
- · At relevant points in the unit, editing exercises and editing checklists are provided so that students can refine their writing.
- . Timed writing activities come at the close of each unit to prepare students for in-
- · A series of learner-friendly appendices are provided at the back of the book to encourage student independence. A glossary of common grammar terms for student reference is included.

#### Unit Organization

Each unit introduces a theme and a writing task and then guides the writer through a five-part process of gathering ideas, organizing an outline, drafting, revising, and editing. As students write, they practice specific skills and put language knowledge to work to produce a short paper that follows academic conventions. The rhetorical and language-related goals of the unit are identified on the opener page.

#### Part 1

Part 1 opens with an image or a quote to spark interest as students begin thinking about the topic. This is followed by a short passage adapted from an authentic text. Students answer questions about the passage that will help them connect thewriter's ideas to their own knowledge and experience. They then move on to a freewriting activity, an unstructured writing task in which they can explore the topic without worrying about organization or grammar.

#### Part 2

In Part 2 students are introduced to a specific rhetorical mode. They begin by brainstorming ideas and vocabulary that they will use to write their essay. They then learn about rhetorical organizational features and read and analyze a student essay. Finally, students produce an outline for the essay they will write later in the unit.

#### Part 3

In Part 3 students develop the ideas from their outline and produce a first draft. This part opens with a second student essay for students to analyze. As they answer questions about the second student model, students review the organizational features learned in Part 2. They are then introduced to specific, level-appropriate language points that will help students shape and structure their writing. Students now write their first draft and, using a peer-review checklist, check each other's writing for organization and clarity of ideas.

#### Part 4

In Part 4 students edit their writing and produce a final draft. This part focuses on particular grammar trouble spots relevant to the theme and the rhetorical style presented in the unit. Following the concise language presentation, students complete practice exercises to help them develop their grammar skills and build confidence. The last exercise always focuses on accuracy and involves editing a piece of writing. Students then move on to editing their own writing, and producing a final draft.

#### Part 5

The final part of the unit is titled "Putting It All Together." This is the summary of the other parts of the unit. Through a series of skill exercises, students review the points covered in Parts 1-4. They are then given the opportunity to write a timed essay using a similar rhetorical focus, but on a different topic. Guidelines for using their time efficiently are suggested. This part also provides students with a comprehensive checklist to review what they have written. The unit closes with suggested tasks for future writing.

#### Rhetorical Focus

#### **Review of Paragraph Structure**

A paragraph is a group of sentences about a topic. A typical paragraph begins with a topic sentence, which introduces the topic. The supporting sentences that follow support the idea in the topic sentence with explanations, reasons, and other details. The concluding sentence brings the paragraph to an end.

#### Formatting a Paragraph

- Leave one-inch margins on the left and right side of the page.
- Indent the first sentence. The rest of the sentences follow each other, so that the paragraph looks like a square with a little space taken out of the corner.
- · Double-space your paragraph.

#### The Topic Sentence

An effective paragraph contains a good topic sentence. A successful topic sentence has the following features:

 It introduces the topic, or what the paragraph will be about. It also contains an idea or opinion about the topic. This idea is called a controlling idea about the topic.

Certain types of insects can benefit a garden.

The topic sentence must not be a simple fact or detail. Instead, it
must contain a specific idea. The idea or opinion must not be too
general, or the topic sentence will be unclear.

There are approximately 4,000 chemicals in cigarette smoke. (fact, not topic sentence)

Smoking is bad. (idea too general for a topic sentence)

Smoking advertisements are a harmful influence on children. (specific idea)

- The topic sentence usually appears as the first or second sentence of a paragraph. Here it is the second sentence.
- Have you ever noticed that closets are getting bigger and rooms are getting smaller? Changes in popular culture can be seen in changes to the typical family home.
- The topic sentence implies the purpose of the paragraph: to explain, narrate, compare, describe, tell cause or effect, demonstrate or argue, or tell steps in a process.

#### Unity and Coherence

#### **Rhetorical Focus**

#### Unity Within a Paragraph

Effective writing must have unity. A paragraph has unity when all the sentences support one single idea:

- The paragraph must have one controlling idea in the topic sentence.
   Otherwise, the paragraph loses focus.
- The supporting sentences must support, demonstrate, prove, or develop the main idea in the topic sentence. If they do not, they will be irrelevant or off-topic and destroy the unity of the paragraph.
- The concluding sentence should restate the idea in the topic sentence to reinforce the main idea for the reader.

#### Coherence in a Paragraph

Coherence in a paragraph means that the ideas have a logical flow: the relationship between the sentences is clear and one idea connects to the next. One way to achieve coherence in a paragraph is to use a pattern of organization, such as time order, spatial order, or order of importance.

#### Important Rules for Acting On Stage

For people who would like to act in the theater, there are several important rules to remember. One rule, often forgotten, is to make sure you face your audience when you are on stage. If you turn away from the audience, they cannot see your facial expressions. Next, make sure that you speak loudly enough. If your audience has difficulty hearing you, they will quickly lose interest. Another important point is to memorize your lines. Rehearse them often—on the train, in the mirror, while you are walking to class—so that you remember them. Finally, perhaps the most important rule of all is to remain calm on stage if you forget your lines. Don't panic and stop speaking because the audience will notice. Instead, make up something to say until you remember your next line. As long as you continue speaking and appear relaxed, the audience will probably not realize that you have made a mistake. In conclusion, following these rules will help ensure a successful stage performance.

A short essay is longer than a paragraph, but like a paragraph it has three basic parts: an introduction, a body, and a conclusion.

- Introduction: the introductory paragraph is the first paragraph of a short essay. It contains a topic sentence and thesis statement.
- · Body paragraph: A short essay has at least one or two body paragraphs. These develop the idea presented in the introduction.
- · Conclusion: The concluding paragraph is the final paragraph and summaries the idea(s) presented in the short essay.

- · A hook is an opening sentence that attracts the reader's attention.
- The sentences after the hook give background information necessary to understand the topic.
- The last sentence in the introduction, the thesis statement, is very important because it gives the topic and the controlling idea of the entire essay.

#### **Body Paragraph**

 An essay has at least one body paragraph in which the writer develops the thesis statement from the introduction. The body paragraph begins with a topic sentence, followed by supporting details.

#### Conclusion

 An essay ends with a conclusion that summarizes or restates the main idea in the thesis statement.

A run-on sentence is not a correct sentence. In a run-on sentence, important punctuation is missing between the clauses. The sentence "runs on" too long and confuses the reader.

 You can correct run-on sentences with a period, a comma and conjunction, or a semicolon.

#### **Dependent Clauses**

A dependent clause is a clause that is not a complete sentence by itself. It has a subject and a verb, but it does not have a complete idea. A dependent clause often starts with a subordinating conjunction like because, before, since, when, after, or while. A dependent clause must always be attached to a main (or independent) clause to make one complete sentence. The dependent clause can come before or after the main clause without changing the meaning, but the punctuation is different.

But I, in the proudest moment of my young life, stood up smartly in **defiance**, and volunteered to be the first.

And in that sweet moment in my personal history, that one moment still more alive for me than so many of the others, I won glory. Monsieur Saint-Jour reached down into the water and came up holding a single oyster, huge and irregularly shaped, in his rough fist. With an oyster knife, he popped the thing open and handed it to me. Everyone was watching now, my little brother pulling away from this shiny, wet object, still dripping and nearly alive.

I took it in my hand, tipped the shell back into my mouth as instructed by Monsieur Saint-Jour, and with one bite and a slurp, I wolfed it down. It tasted of seawater ... and flesh ... and somehow ... of the future.



### Introduction

- The middle sentences provide the background.
- The thesis statement tells why the object or event of description is important to the writer.

### **Body Paragraphs**

- Most of the description is in the body paragraphs.
- Adjectives and adverbs make the experience more vivid.
- The scene is often described with prepositions and prepositional phrases that specify location or position in space.
- Comparisons, such as similes, can make the writing more descriptive, familiar, and expressive.

## **Describing Feelings**

A narrative is a story. It has an introduction that engages the reader's interest, a body that gives details about the main event or action in the story, and a conclusion that describes the outcome.

### Introduction

- The hook gets the reader's attention.

#### Showing Sequence in Narrative Essays

In narrative essays, we use time expressions to make the chronological sequence of events clear.

- · We use connectors (time adverbs) such as then, finally, or eventually to link sentences within a paragraph.
- We use subordinating conjunctions to link clauses within a sentence.

#### Time Adverbs

We use time adverbs such as afterward, after that, eventually, finally, later, later on, now, then, and suddenly as connectors. These connectors usually appear at the beginning of a sentence. When they do, they are immediately followed by a comma.

▲ Then is an exception. It is not followed by a comma.

Our train was running late. Finally, it arrived. We got on board the train. Then we realized that we did not have money for the fare.

# Subordinating Conjunctions

We use subordinating conjunctions such as as soon as, before, after, when, and while in complex sentences as connectors. Complex sentences contain a main (independent) clause and a dependent clause.

. The main clause expresses the principal and independent idea of the sentence. The dependent clause expresses additional information about the main idea (for example, where or when it happened) but would be meaningless without the main idea. Dependent time clauses tell us when something happened.

 Subordinating conjunctions establish the time relationship between the dependent time clause and the main clause in the sentence. The subordinating conjunction starts the dependent clause, but the clauses can come in either order. We use a comma when the time clause comes before the main clause. time clause main clause After our parents left the hotel, we went into the street. While we were unpacking, the lights went out. main clause time clause We went into the street after our parents left the hotel. The lights went out while we were unpacking.

#### Using the Past Continuous in Narrative Essays

In a narrative, you often need to describe actions in progress, or to describe background actions.

- To form the past continuous use was/were and the base form of the verb + ing.
- Use the past continuous to talk about activities that were in progress at a specific time in the past. The activities began before the specific time and may also have continued after that time.

At three o'clock we were walking home from school. My friend was riding his bicycle.

- Also use the past continuous to describe background actions. The sun was going down and the children were still playing on the grass.
- ▲ We don't usually use stative verbs (be, know, own, mean, seem, understand, love, believe, etc.) in the past continuous. We use the simple past instead.



#### **Past Time Clauses**

Past time clauses can be used to describe the relationship between two or more events.

- Past time clauses are dependent clauses. They must be attached to a main (or independent) clause.
- Past time clauses can contain verbs in the past continuous or simple past, and usually begin with subordinating conjunctions such as before, when, while, and after.
- The past time clause can come before or after the main clause; however, if the past time clause comes first, separate it from the main clause with a comma.

# Wireless: Bhutan's Hills Are Alive with Sound of Cell Phones

The ancient way of life continues in the Himalayan Kingdom of Bhutan. Thimpu, home to the royal family and the government, may be the world's only capital city without traffic lights. But while Bhutan may get by without traffic lights, it has realized it cannot miss out on the digital revolution. Soon, thousands of cell phones may ring across the mountain kingdom.

Engineers are traveling across the country, setting up rural telecommunications systems. This project will connect the Bhutanese with each other and the outside world through voice and Internet technology. The mountain landscape limits the technology that can be used, so wireless is the best solution.

For the engineers, it is a challenging project. Teams bringing equipment will face long pony rides through the mountains. Some villages are so far away that it can take four days to walk there from the nearest road. There are no trains or flights. Engineers also could get sick in the high mountains where some villages are above 3,600 meters (12,000 feet).

For the Bhutanese, this will bring important benefits, such as distance learning and tele-medicine. "The project is a big change in terms of education and communication for the rural people," said a Bhutanese official. In the villages, people are hoping they can benefit from that kind of access to technology without making too many changes to their ancient way of life.

#### **Opinion Organization**

In an opinion essay, the writer tries to convince the reader of a point of view on a controversial issue (something that people disagree about).

#### Introduction

- The hook introduces a controversial issue.
- The hook may be a short story or an anecdote, a question, or a surprising statement or fact that makes the reader want to know more.
- The middle sentences explain why the issue is important by giving background information. This background information explains the issue with details about the history or the people involved, what they want, or how it affects them.
- The thesis statement at the end presents the writer's point of view.

#### Body Paragraph

- The topic sentence has a controlling idea that supports the writer's main argument in the thesis.
- The following sentences support the topic sentence with reasons, facts, and explanations to help the reader understand the writer's point of view.
- The body paragraph often includes a statement that describes the
  opposing opinion. This is called the counter-argument. The writer then
  argues against the counter-argument. This is called a refutation. In the
  refutation, the writer points out weaknesses in the counter-argument, and
  shows how his own argument is stronger.

#### Conclusion

 This restates the writer's opinion, but often using different, more persuasive language.

# Facts and Opinions

Writers use both facts and opinions to support their position or argument. They state their opinion and then back it up with facts. The difference between facts and opinions is shown below.





In order to make an opinion essay as persuasive as possible, the writer includes a counter-argument and a refutation.

- . The counter-argument is the opposing opinion. It disagrees with the writer's position. By including the counter-argument, the writer shows an understanding of other points of view.
- The refutation is the writer's response to the counter-argument. In the refutation, the writer shows why the counter-argument is weak and the writer's position is strong. The refutation may also address doubts the reader may have about the writer's position.

# Using Quantity Expressions in Opinion Essays

In an opinion essay, writers often make general statements about a group or category. It is important to avoid making a statement that is true for some, but not for all members of a group or category. This is called an overgeneralization. Compare the following statements.

Cats hate water.

Most cats hate water.

The first statement suggests that all cats in the world hate water. It is untrue because some cats, such as tigers, are good swimmers and enjoy being in water. In the second statement, the writer uses the quantity expression most. The quantity expression qualifies, or limits the generalization, so that the statement is true.

#### Quantity Expressions

The following patterns guide the use of quantity expressions:

. Most, a lot of, and some are used with both plural count nouns and noncount nouns.

Most dormitories have Internet access.

Some cafeterias offer healthy alternatives to traditional student food.

 Much and a little are used with noncount nouns. (Much is not usually used in affirmative statements. Use a lot of instead.)

Some people have a lot of intelligence, but they do not have much

Students might have a little money left for entertainment after paying expenses.

· Many, several, and a few are used with plural nouns.

Many Web sites charge a fee for information.

A few uncooperative participants can destroy a meeting.

# Using Connectors to Show Support and Opposition

When we explain an opinion, we can use connectors to clarify the relationship between ideas. Connectors can be used to signal that the second idea will support the first in some way. They can also be used to contrast the first idea with an opposite or very different idea. When they introduce an independent clause, the connector is followed by a comma.

#### **Connectors That Show Support**

 One way to support an idea is to give an example that illustrates the idea. Connectors like for example and in particular introduce examples.

Most people are willing to spend money to make their lives easier; for example, nearly every new house has an automatic garage door opener. Children should avoid junk food; in particular, they should stay away from sugary snacks.

 A second way to show support is to add facts or explanations that clarify the idea.

The automobile industry is responding to consumer demands for more fuel-efficient cars; in fact, the number of available models has tripled in the past three years.

# **Connectors That Show Opposition**

It is sometimes difficult for the writer to show that two ideas are opposed to each other. Connectors like *however*, *in contrast*, *on the other band* help the writer focus the reader's attention on differences.

I'm late every morning; however, I never get into trouble.

Many people enjoy listening to CDs; in contrast, live concerts are more exciting.

# **Learning About Differences**

Despite my success, I still wanted to study and teach. So when I was offered a Fulbright scholarship in 1965, I jumped at the chance to get a PhD in the United States. This was my third trip abroad. As a Boy Scout I had gone to Niagara Falls, Canada, in 1955 and to Japan and the Philippines in 1959. But this time I was on my own, and I was in for some surprises. At first the University of Colorado campus in Boulder was quite a shock. In Bangladesh, students never called professors by their first names. If one spoke to "sir," it was only after being invited by "sir" to speak, and then one spoke in enormously respectful terms. But in Boulder, teachers seemed to consider themselves friends of the students. I often saw faculty and students sprawled out on the lawn barefoot, sharing food, joking, and chatting. Such familiarity was totally unthinkable in Bangladesh. And as for the young female students in Colorado, well, I was so shy and embarrassed I did not know where to look. At Chittagong College, female students were the minority. Of a student body of eight hundred, no more than one hundred and fifty were women. Women were also segregated. They were usually confined to the Women's Common Room, which was offlimits to male students. Their participation in student politics and other activities was limited. When we staged plays, for example, women were not allowed to participate, so men wearing women's dress and makeup would take on female roles.

My female students at Chittagong University were extremely shy. When it was time for class, they would **huddle** in a group just outside the Teachers' Common Room and then follow me to class, **clutching** their books and looking down at their feet so as to avoid the stares of the boys. Inside the classroom they sat apart from the boys, and I learned not to ask them questions that could possibly embarrass them in front of their classmates. I never talked to them outside the classroom.



A comparison and contrast essay describes the qualities of a subject or idea by discussing the similarities and differences it shares with a different subject or idea.

A comparison and contrast essay can be organized in two different ways:

- · By comparing and contrasting a number of issues point-by-point
- · By focusing first on the similarities and then the differences.

#### Introduction

- Presents the subject that is to be compared or contrasted
- Ends with a thesis statement that focuses the comparison or contrast

## **Body Paragraphs for Point-by-Point Essays**

- There are two body paragraphs, each with a clear topic sentence.
- · Each body paragraph presents one main point to be compared or contrasted between the two subjects.
- · Within each body paragraph, the topic sentence states the point of comparison or contrast between the subjects. The supporting sentences that follow provide two or three examples.
- The body paragraphs use sequence transitions, such as first, second, furthermore, etc., to connect the point-by-point analysis within the paragraph.

## **Body Paragraphs for Similarities and Differences Essays**

- There are two body paragraphs, each with a clear topic sentence.
- One body paragraph is devoted to similarities between the two subjects, and one body paragraph is devoted to differences.

## Conclusion

 This allows the writer to summarize the differences and similarities and state his or her feeling about the topic.

# A Walk on Sunday Afternoon

I enjoy spending my Sunday afternoons outside the house. I cannot have the same experience in the United States that I had in Mexico when I was a child, but I have found a place that is similar to my home. Willowbrook Mall in Houston, Texas, is my favorite place in the U.S. to take a walk because it reminds me of Moreda Street in Morelia, Mexico. They are very different but also similar in some ways, especially on a Sunday afternoon.

In Morelia, families leave church and go for a walk along Moreda Street on Sunday afternoon. Often people stop at an outdoor café and have an ice cream or coffee and watch people walk by. I sit in a food court where I can drink a coffee with my friend, as I watch teenagers and families walking through the mall. When I see them, I remember how life was when I was a child.

Despite their similarities, Moreda Street and Willowbrook Mall are very different. Willowbrook Mall is more modern. On the one hand, Moreda Street has old colonial buildings and beautiful old trees that shade the street. It is also quiet. On the other hand, Willowbrook Mall is new and the lights are bright, and loud music plays in the stores. The people on Moreda Street also have more traditional ways. Men wear attractive, conservative suits and women wear light summer dresses. Fathers watch their teenage daughters closely and do not let their daughters hold hands with boys. In contrast, many teenagers go to Willowbrook Mall without their parents, and boyfriends and girlfriends walk with their arms around each other. When I see them, I realize that my daughter will have a different experience growing up in Houston than I did in Moreda. Then, I worry about her, and I miss Moreda Street, where life is more traditional.

It is interesting to see how people and places from different countries can be similar and different at the same time. Moreda Street and Willowbrook Mall are very different in appearance and culture, but they are also similar because they are both places where people like to go to relax on a Sunday afternoon.

Quetzaltenango is known as "Xela" (pronounced shey-la), which is a lot easier to say! Second, both cities have a "Central Park" where people like to go and walk. Although Central Park in Xela is smaller, its tropical flowers and colonial architecture mean it is just as beautiful as New York's. Furthermore, when you walk around Xela, you find many tourists and people from other countries, just like in New York. For me, this means conversations in Xela are just as interesting as conversations in New York.

Despite their similarities, these cities are different. Life in Xela is more colorful and the pace of life is slower. For this reason, whenever I return to Xela, it is like an escape. When I arrive, the first thing I notice is the color. In New York, many people wear black to be stylish, but in Xela stylish clothing is the rainbow-colored clothing of the indigenous people. And because Xela is smaller, the beautiful green mountains outside the city are always visible. The second thing I notice is the pace of life. They say New York never sleeps, and it must be true, because I always see people walking and cars on the streets.

even late at night. In the evening, my Guatemalan city definitely sleeps. Some younger people go out dancing and some families take a walk in the city's Central Park, but by ten o'clock the streets are pretty deserted. On the other hand, New Yorkers are often in such a hurry, they don't even stop to eat. For breakfast they buy food on the street, and eat it while they are walking or on the subway. At lunch they order food from work and eat at their desks. In Xela people eat their breakfast at home and most come home from work for a much more relaxed and longer lunch.

In conclusion, these are the two cities I love. For me, both are home, are unique, and are filled with interesting people. These places represent the best of both worlds. New York is more hurried and rushed when I need energy, and Xela gives me a slower pace when I need to relax. Together they keep me balanced.

   -er. If the adjective or adverb ends in a single vowel and consonant,
   double the consonant.



## Rhetorical Focus

## Cause and Effect Organization

A cause and effect essay explains why something happens. Both causes and effects are examined in longer essays. Your short essay will focus only on causes that lead to an event or situation.

#### Introduction

- The hook engages the reader's interest by personalizing the topic or showing why it is important for the reader to know about it.
- The middle sentences describe the event or situation that is the result of the causes. This background information helps the reader understand the relationship between the causes and the effects.
- The thesis statement at the end of the introduction states two causes that lead up to the event or situation. It may also include a comment by the writer that explains why it is important to understand the causes of the event

### **Body Paragraphs**

- There are two body paragraphs in the essay, which support the thesis statement by explaining the causes in detail.
- Each body paragraph begins with a topic sentence that states one cause for the event or situation.
- The sentences that follow support the idea in the topic sentence. These supporting sentences include details such as examples, description, reasons, and facts to help the reader understand the relationship between the cause and the event.

## Conclusion Conclusion

- The conclusion restates the thesis statement, often using different language.
- It summarizes the main causes and their relationship to the event.
- It may include a comment by the writer that explains why it is important to understand the causes of the event

## Why Students Are Poor

It is easy to recognize a college student because he or she is carrying books and usually wearing old pants or jeans and a T-shirt. You will not see a college student driving a new car. Instead, you will see him at a bus stop or on a bicycle. And at mealtimes, a college student is more likely to be eating a slice of pizza than dining in a fine restaurant. Very few college students have extra money to spend on clothes, cars, or good food. There are two main reasons why being poor is an unavoidable part of the college experience.

The first reason college students are poor is that they cannot work full-time. An eighteen year-old is an adult with the needs and wants of an adult; however, if that young person is taking courses at a university or a community college, he or she must spend as much time as possible studying. Therefore, the student has to sacrifice the extra money that a job would provide in order to have the freedom to concentrate on classes.

A second reason college students have little money is that they have other expenses that working adults do not have. A college student must pay tuition fees every semester. A full-time student usually takes three or four classes each semester, and the fees for these classes can cost thousands of dollars per year. Also, students need to buy several expensive textbooks each semester. A single textbook can cost as much as a hundred dollars. Other necessary expenses include computers, paper, pens, notebooks, and other items needed for school projects.

Many students cannot afford to attend college full-time, so they have a job and go to school part-time, but they are still poor because of the cost of attending college. Fortunately, the causes of student poverty

are temporary. Most students do not mind because they have the hope that a college degree will get them a good job and they will have good prospects in the future.

So even though he might want to keep the ball and make all the shots, he must focus on passing the ball to the player who has the best chance of scoring. He cannot think only about himself if he wants his team to win.

In conclusion, the two contributing factors to a successful career in athletics are physical ability and a strong mind and character. 

# Appendix I: The Writing Process

#### 1. Brainstorming

Before you begin to write, gather information about the topic. Then, brainstorm ideas and vocabulary related to the topic. Read your assignment carefully so that your finished product will meet your instructor's expectations.

Strategies: Read about the topic and discuss it with your classmates. Look at pictures or diagrams, to help you come up with ideas.

#### 2. Creating an outline

Decide which ideas you will use in your essay. Cluster ideas into logical parts. This may be in the form of a chart, a web, or a list of main ideas. Write an outline or plan for your paper.

▶ Strategies: Look at models that are similar to the writing that you want to do. Learn ways to organize and sequence your ideas. Create a visual plan for your paper.

#### 3. Writing a First Draft

Expand your outline into a draft by rewriting your notes into full sentences. At this stage, don't worry about mistakes. When you have finished, ask a classmate to read your work and give you feedback.

Strategies: Evaluate your outline as you write. Take out ideas that do not support your argument; add clarification or examples. Check your work to make sure your writing is clear and accomplishes the goals of the assignment.

#### 4. Editing

Now apply your knowledge of grammar and mechanics, and correct any mistakes that you notice. Review the feedback you received from your classmates.

Strategies: Separate yourself from the ideas so that you can focus on clarity at the sentence level. If possible, put your paper aside for a few hours before you edit. Read your essay sentence by sentence. (Some writers read a paper backwards so as not to be distracted by content.)

#### 5. Writing a Final Draft and Submitting Your Work

Rewrite your draft so that it looks neat and has all the features of a finished college paper. Some writers type their papers; others write by hand.

➤ Strategies: Make sure your paper has the correct format. Make sure your name and the date are on the paper, and that there is a title.

# Appendix II: Punctuation

#### Commas

A comma (,) is used to separate information from other parts of the sentence.

- 1. A comma is used to separate items in a series. Use and before the last item if listing three or more items.
  - · We made rice, chicken, salad, and cake.
- A comma is used to separate an introductory word or phrase.
  - At the end of the day, my husband and I sit on the sofa and talk about our day.
- 3. A comma is used after a dependent clause when the dependent clause precedes (or introduces) an independent clause.
  - · When the power went off, we could not listen to the radio.
- 4. A comma is used to separate two main clauses when there is a conjunction such as and, but, or so shows a relationship between them.
  - The temperature was below freezing, but we were warm.
- 5. A comma is used to separate an appositive from the rest of the sentence. An appositive appearing after any noun in a sentence is set off with commas.
  - We used to visit North Beach, a Bohemian neighborhood in San Francisco.
  - · The speaker, an Ecuadorian economist, supported his points with facts and statistics.

#### Periods

Periods (.) are used to mark the end of a sentence.

Colons (:) are used to introduce a list of items. They can be particularly helpful when writing thesis statements because they allow the writer to introduce the

Colons must be preceded by an independent clause. They can be followed by a group of words, phrases or, in some cases, clauses.

 In order to build a tree house, you will need the following items: nails, a hammer, boards, and a tape measure.

#### Semicolons

Semicolons (;) are used at the end of a sentence. They follow the same rules as periods; however, they are only appropriate if the relationship between the two sentences is close.

- Semicolons are used between two separate sentences.
  - · They help each other; she does the bookkeeping while he takes care of customers.
- 2. Semicolons are used when two sentences are joined by a connector such as bowever, or therefore.
  - · The Earth's oceans still hold many secrets; however, new technology is helping scientists to understand them better.

#### Apostrophes

Apostrophes (') are used to show possession.

- When a noun is singular, add an apostrophe and s to show possession. In the first example, the writer has one cousin.
  - We went to my cousin's house.
- 2. When a noun is plural, put the apostrophe after the plural s. In the next example, the writer has more than one cousin.
  - We went to my cousins' house.
- 3. When a noun ends in s, you may add the apostrophe + s after the final s or just the apostrophe.
  - My boss' car was ridiculously expensive.
  - My boss's car was ridiculously expensive.

Apostrophes are also used in contractions. (Note, however, that contractions are not appropriate in most academic writing.)

#### **Quotation Marks**

Quotation marks ("...") are used to show that you are repeating or quoting someone

Put quotation marks around only the exact words you take from someone else's speech or writing. Use a comma to separate the quote from the rest of the sentence.

conditional sentence A sentence that expresses a real or unreal situation in the if clause, and the (real or unreal) expected result in the main clause.

If I have time, I will travel to Africa.

If I had time, I would travel to Africa.

countable noun A common noun that can be counted. It usually has both a singular and a plural form.

orange - oranges

woman - women

definite article The word the in English. It is used to identify nouns based on assumptions about what information the speaker and listener share about the noun. The definite article is also used for making genera statements about a whole class or group of nouns.

Please give me the key. The scorpion is dangerous.

dependent clause A clause that cannot stand alone as a sentence because it depends on the main clause to complete the meaning of the sentence. Also called subordinate clause.

I'm going home after he calls.

determiner A word such as a, an, the, this, that, these, those, my, some, a few, and three that is used before a noun to limit its meaning in some way. those videos

**future** A time that is to come. The future is expressed in English with **will**, **be going to**, the simple present, or the present continuous. These different forms of the future often have different meanings and uses.

I will help you later.
David is going to call later.
The train leaves at 6:05 this evening.
I'm driving to Toronto tomorrow.

**gerund** An **-ing** form of a verb that is used in place of a noun or pronoun to name an activity or a state.

Skiing is fun. He doesn't like being sick.

if clause A dependent clause that begins with if and expresses a real or unreal situation.

If I have the time, I'll paint the kitchen.
If I had the time, I'd paint the kitchen.

indefinite article The words a and an in English. Indefinite articles introduce a noun as a member of a class of nouns or make generalizations about a whole class or group of nouns.

An ocean is a large body of water.

independent clause See main clause.

indirect object A noun or pronoun used after some verbs that refers to the person who receives the direct object of a sentence.

John wrote a letter to Mary. Please buy some milk for us.

**infinitive** A verb form that includes to + the base form of a verb. An infinitive is used in place of a noun or pronoun to name an activity or situation expressed by a verb.

Do you like to swim?

intransitive verb A verb that cannot be followed by an object.

We finally arrived.

main clause A clause that can be used by itself as a sentence. Also called *independent clause*.

I'm going home.

main verb A verb that can be used alone in a sentence. A main verb can also occur with an auxiliary verb.

i ate lunch at 11:30. Kate can't eat lunch today. modal The auxiliary verbs can, could, may, might, must, should, will, and would. They modify the meaning of a main verb by expressing ability, authority, formality, politeness, or various degrees of certainty. Also called modal auxiliary.

You **should** take something for your headache. Applicants **must** have a high school diploma.

**negative statement** A sentence with a negative verb.

I didn't see that movie.

noun A word that typically refers to a person, animal, place, thing, or idea.

Tom rabbit store computer mathematics

noun clause A dependent clause that can occur in the same place as a noun, pronoun, or noun phrase in a sentence. Noun clauses begin with wh-words, if, whether, or that.

I don't know where he is

I wonder if he's coming.

I don't know whether it's true.

I think that it's a lie

**noun phrase** A phrase formed by a noun and its modifiers. A noun phrase can substitute for a noun in a sentence.

She drank milk.

She drank chocolate milk.

She drank the milk.

object A noun, pronoun, or noun phrase that follows a transitive verb or a preposition.

He likes pizza. She likes him. Go with her.

Steve threw the ball.

passive sentence Passive sentences emphasize the receiver of an action by changing the usual order of the subject and object in a sentence. In the sentence below, the subject (The letter) does not perform the action; it receives the action or is the result of an action. The passive is formed with a form of be + the past participle of a transitive verb.

The letter was mailed yesterday.

past continuous A verb form that expresses an action or situation in progress at a specific time in the past. The past continuous is formed with was or were + verb + -ing. Also called past progressive.

A: What were you doing last night at eight o'clock? B: I was studying.

past participle A past verb form that may differ from the simple past form of some irregular verbs. It is used to form the present perfect, for example.

I have never seen that movie.

asal verb A two- or three-word verb such as down or run out of. The meaning of a phrasal is usually different from the meanings of its vidual words.

he turned down the job offer. Don't **run out of** gas on the freeway.

ase A group of words that can form a mmatical unit. A phrase can take the form of a in phrase, verb phrase, adjective phrase, adverbial ase, or prepositional phrase. This means it can act 1 noun, verb, adjective, adverb, or preposition.

The tall man left. lee hit the ball.

She spoke too fast. They ran down the stairs.

eposition A word such as at, in, on, or to, that ks nouns, pronouns, and gerunds to other words.

epositional phrase A phrase that consists of a eposition followed by a noun or noun phrase.

under the table

resent continuous A verb form that indicates that activity is in progress, temporary, or changing. It formed with be + verb + -ing. Also called present rogressive.

I'm watering the garden. Ruth is working for her uncle.

resent perfect A verb form that expresses a onnection between the past and the present. It ndicates indefinite past time, recent past time, or continuing past time. The present perfect is formed with have + the past participle of the main verb.

I've seen that movie.

The manager has just resigned.

We've been here for three hours.

pronoun A word that can replace a noun or noun phrase. I, you, he, she, it, mine, and yours are some examples of pronouns.

quantity expression A word or words that occur before a noun to express a quantity or amount of that noun.

a lot of rain few books four trucks

simple past A verb form that expresses actions and situations that were completed at a definite time in the past.

Carol ate lunch.

She was hungry.

simple present A verb form that expresses general statements, especially about habitual or repeated activities and permanent situations.

Every morning I catch the 8:00 bus. The earth is round.

stative verb A type of verb unit is that docum, used in the continuous form because it expresses a condition or state that is not changing. Know, love, see, and smell are some examples.

subject A noun, pronoun, or noun phrase that precedes the verb phrase in a sentence. The subject is closely related to the verb as the doer or experiencer of the action or state, or closely related to the noun that is being described in a sentence with be.

Erica kicked the ball. The park is huge.

subordinate clause See dependent clause.

superlative A form of an adjective, adverb, or noun that is used to rank an item or situation first or last in a group of three or more.

This perfume has the strongest scent.

He speaks the fastest of all.

That machine makes the most noise of the three.

tense The form of a verb that shows past, present, and future time.

He lives in New York now.

He **lived** in Washington two years ago.

He'll live in Toronto next year.

time clause A dependent clause that begins with a word such as while, when, before, or after. It expresses the relationship in time between two different events in the same sentence.

Before Sandy left, she fixed the copy machine.

time expression A phrase that functions as an adverb of time.

She graduated three years ago.

I'll see them the day after tomorrow.

transitive verb A verb that is followed by an object.

I read the book.

uncountable (noncount) noun A common noun that cannot be counted. A noncount noun ha no plural form and cannot occur with a, an, or a number.

weather mathematics information

verb A word that refers to an action or a state.

Gina closed the window.

Tim loves classical music.

verb phrase A phrase that has a main verb and objects, adverbs, or dependent clauses that comp the meaning of the verb in the sentence.

Who called you? He walked slowly.
